



Irish Dance Workshop mit Champion Dancer Anne Murphy for beginners, refreshers and advanced for children and adults on 27th and 28th April 2024 in Munich

The teacher Anne Murphy:

Anne Murphy began her dancing career at the age of 4 at the Cowie-Ryan School of Irish Dancing in her native Cobh, County Cork, Ireland. At the age of 12, she won her first championship title in her age group. Anne came to Munich in 1973 to work here and long before Riverdance and Lord of the Dance she entertained audiences at folk festivals throughout Germany and Europe. In 1989 she began teaching the children in traditional Irish dance in Munich at the request of some Irish mothers and the pastor of the Irish parish of St. Killians.

Course 1: Softshoes for beginners and refreshers

Softshoes is the ballet-like part of traditional Irish dance. In this workshop you will learn the basics of Irish dance as well as technique, rhythm and timing. Familiarize yourself with counting and dancing to Irish music. (a good combination with course 2)

Course 2: Ceili for beginners, refreshers and advanced

Anne will practice some Irish and Scottish group dances with us. Group dances are easy to learn and a lot of fun. (a good combination with course 1 or 3)

Course 3: Softshoes for Advanced and Refreshers

If you're ready to improve, this workshop is for you! We will be working on more complex steps in both reel and jig timing. Please prepare 1 – 2 Reel and Slip Jig steps for the audition so that Anne can see how far you have come. (a good combination with course 2)

Course 4: Hardshoes for Beginners and Refreshers

If you already have the basics in softshoes in your feet and legs, then expand your dance repertoire in the typical Irish tap dance shoes, the hard or heavy shoes with this workshop. Here you will get to know steps, technique, rhythm in a small choreography.

Course 5: Hardshoes for Advanced and Refresher

In this course, Anne will help you improve your jig and hornpipe steps and techniques. Please prepare 1 – 2 Treble Jigs and Hornpipe Steps for the audition so that Anne can see how far you have come.
